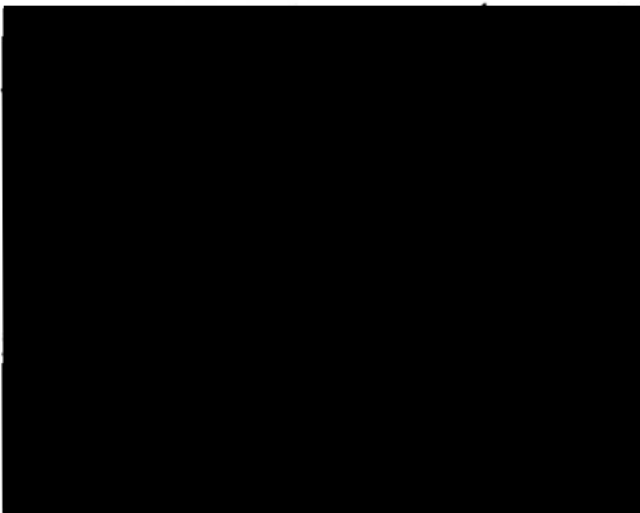
NOTE
